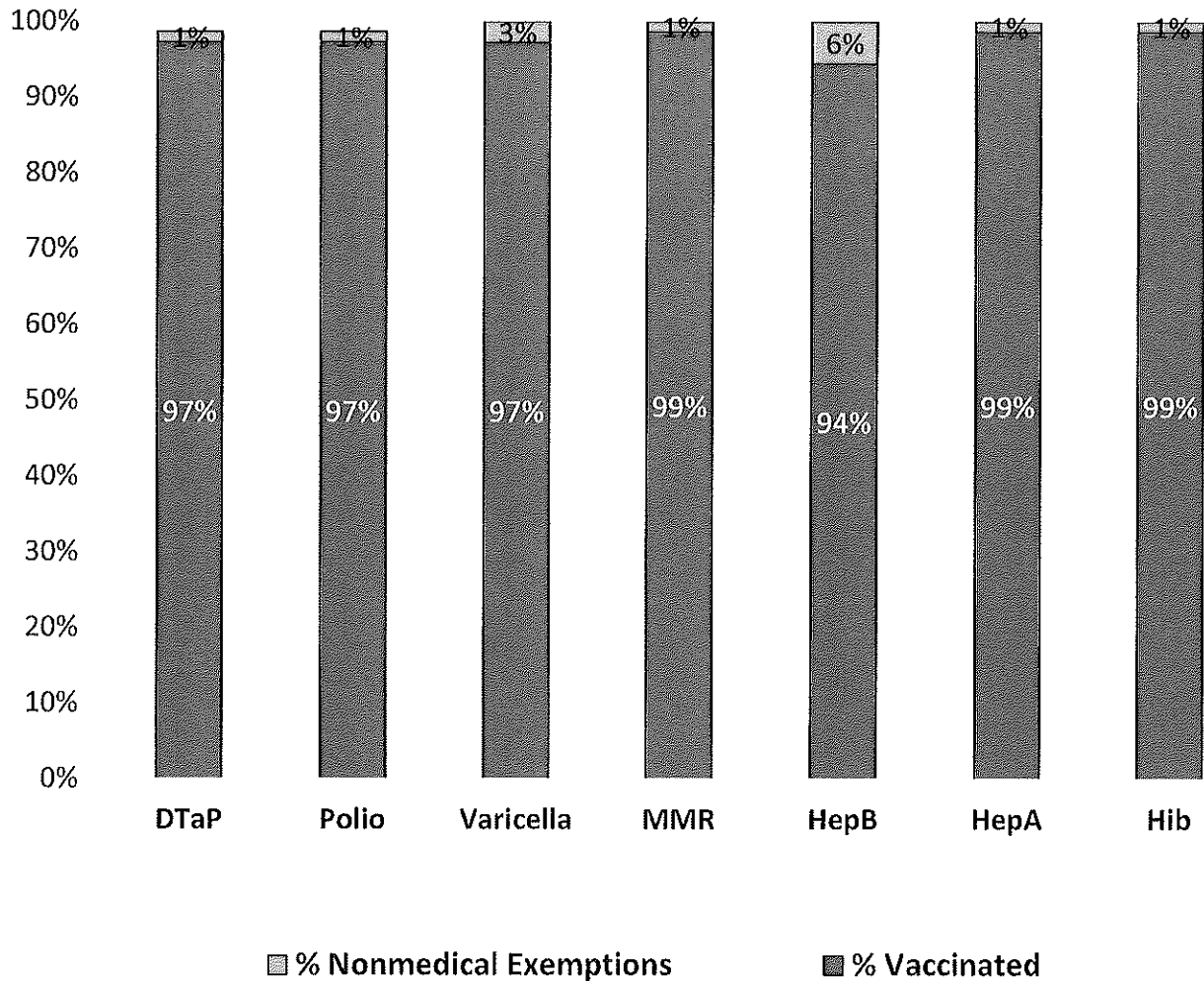


How many children at The Portland Montessori School are vaccinated: March 2024*



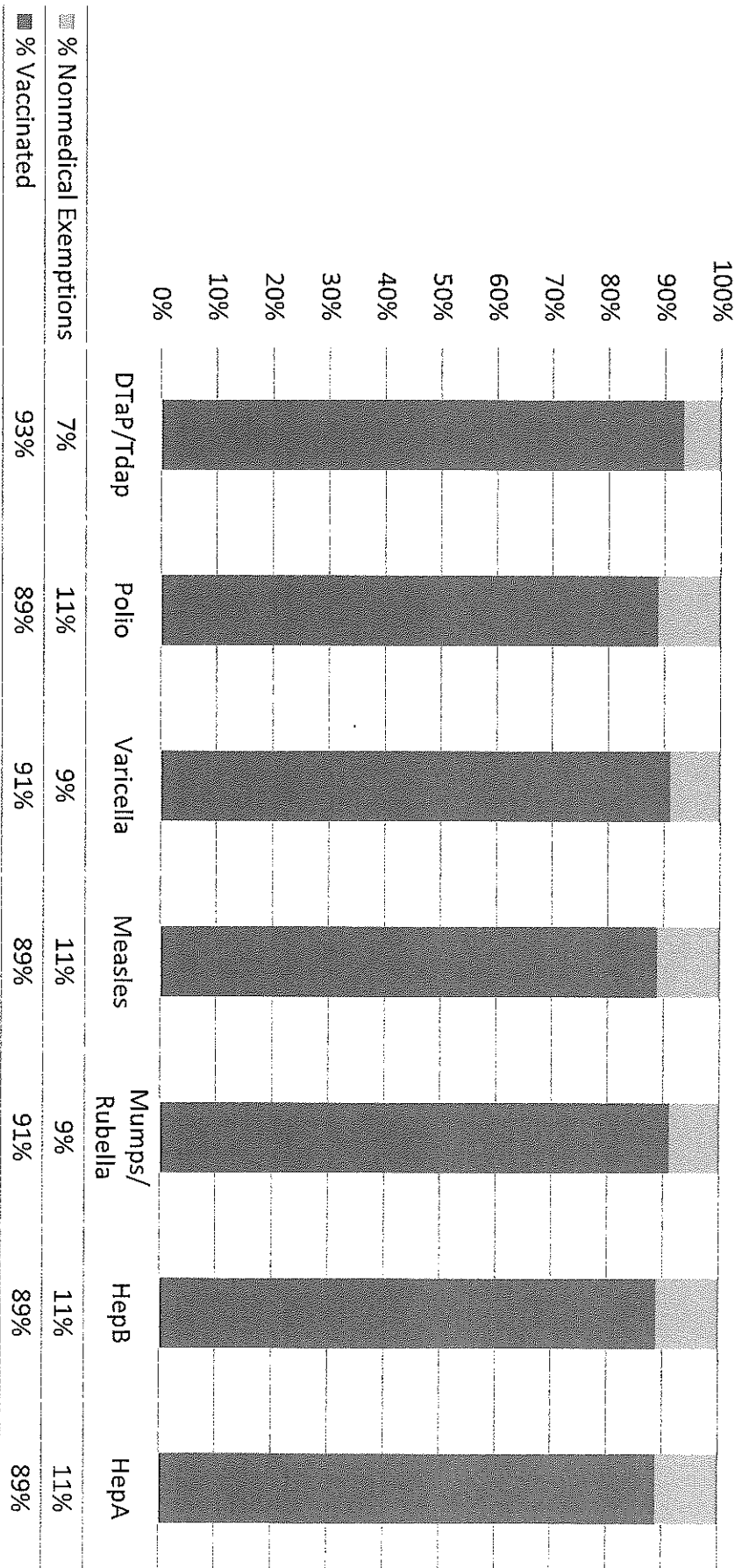

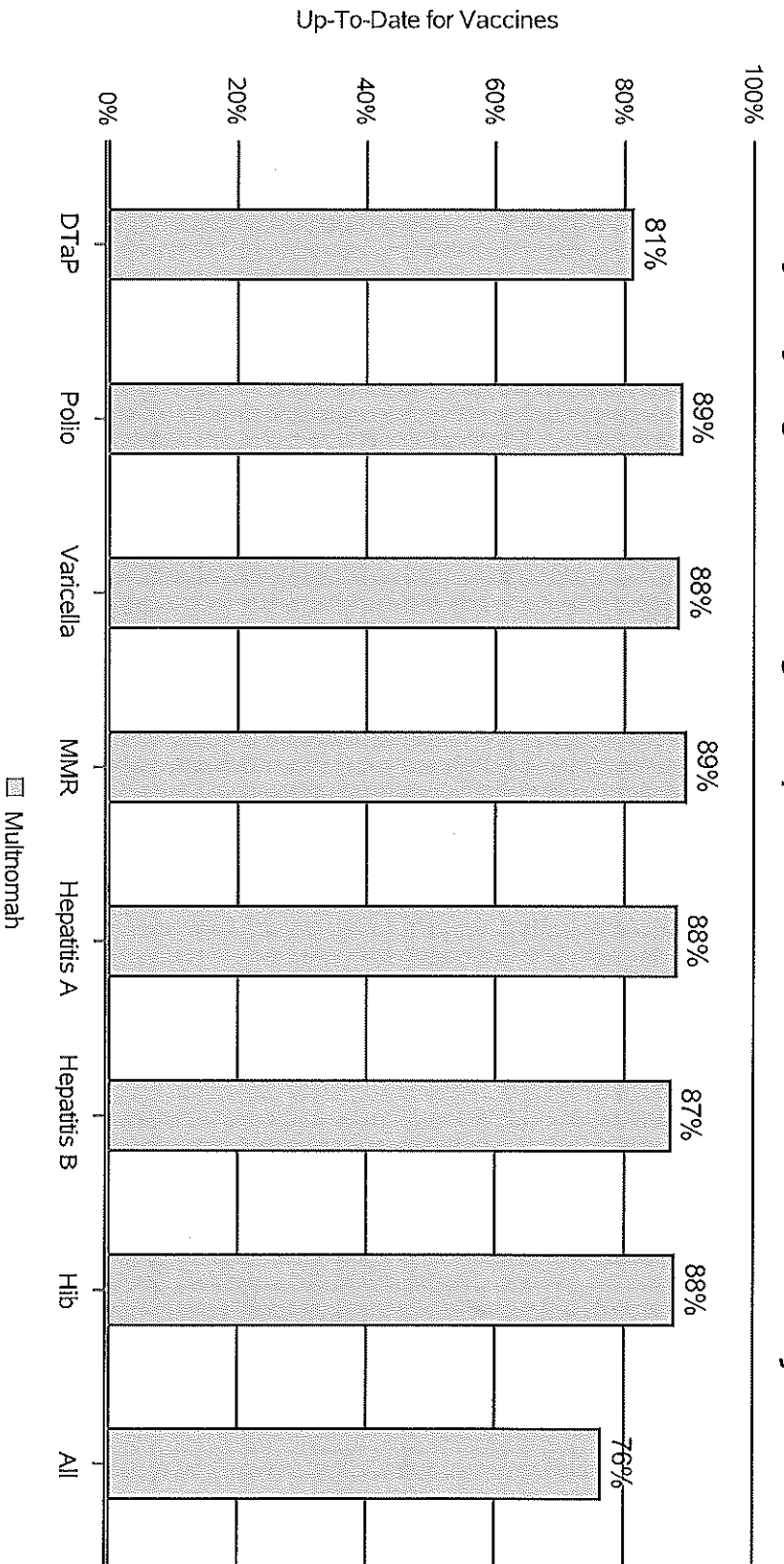

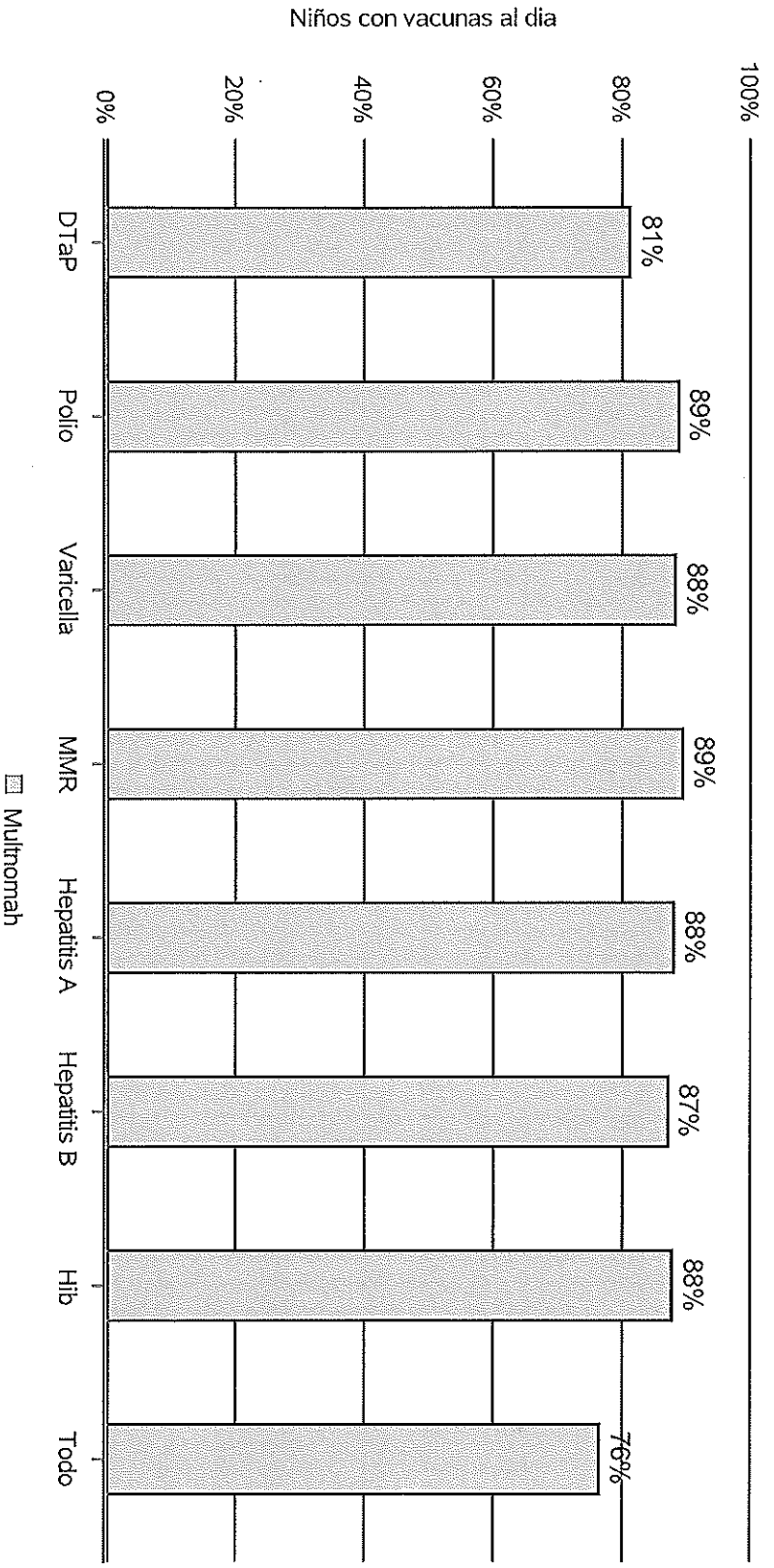

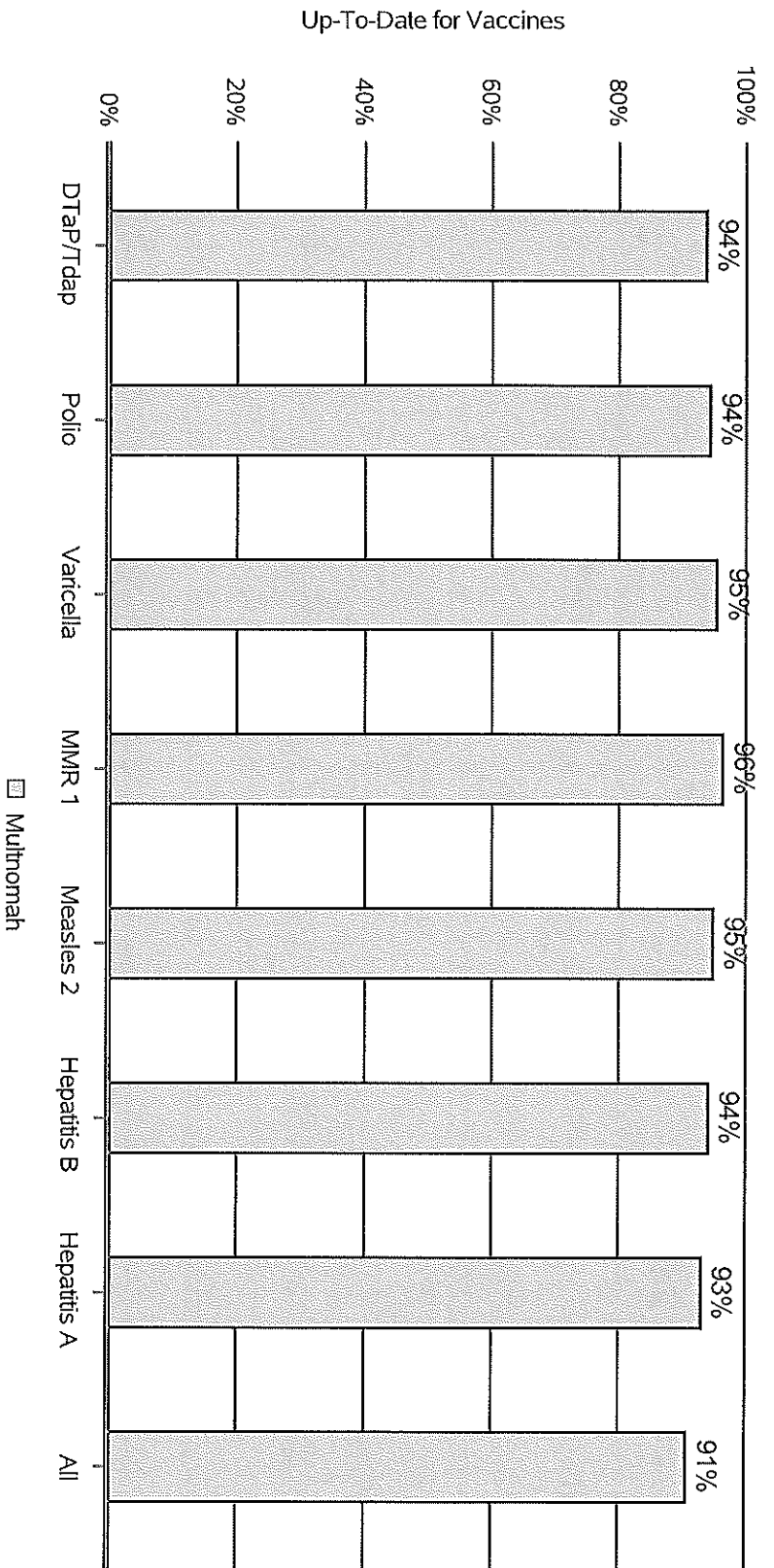

How many students* are up-to-date on vaccines in Multnomah County



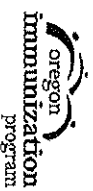

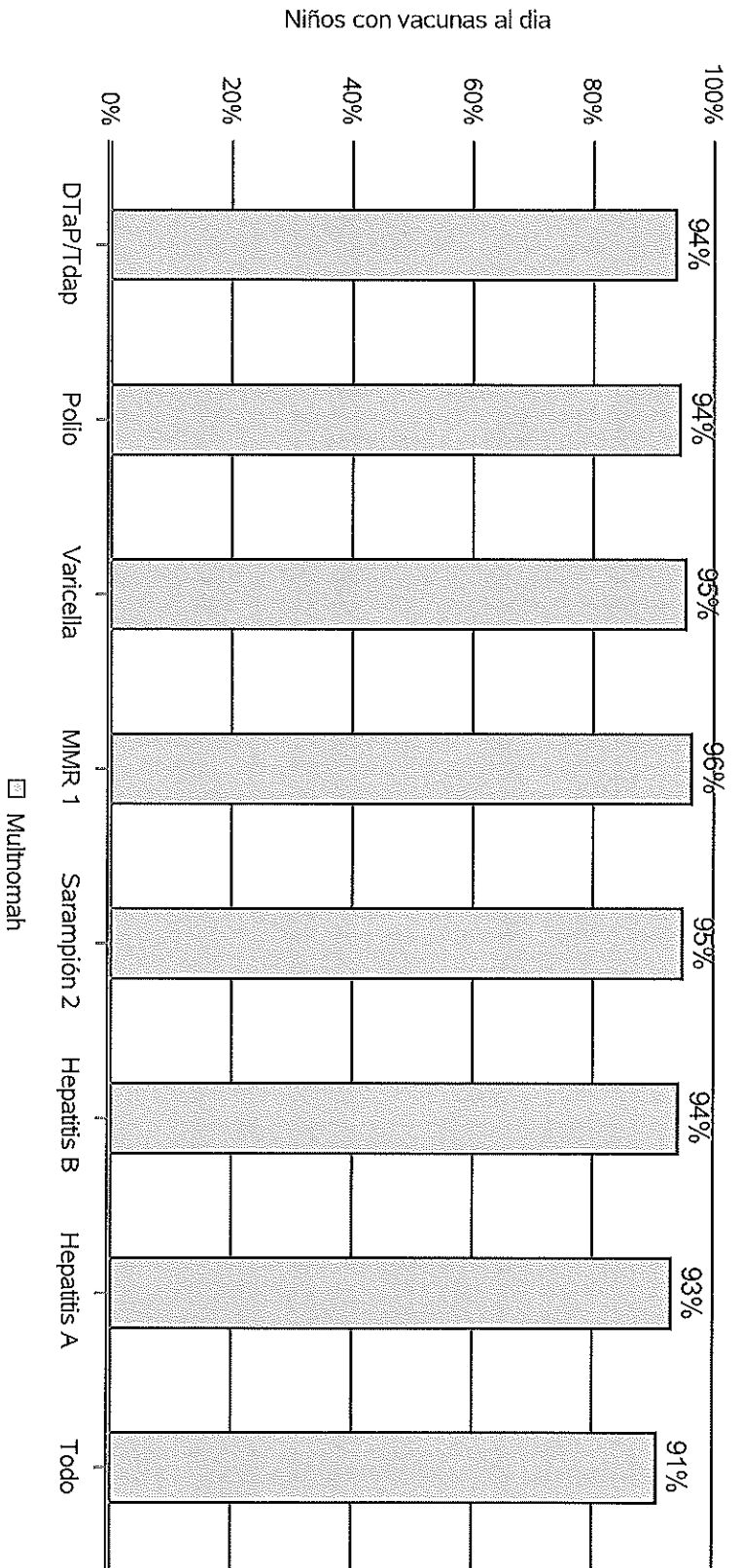
